Notwithstanding the foregoing, this agreement shall not apply to the Western Washington County Firefighters Association event sponsors or their officers, agents, employees, and volunteers for its own separate negligence in connection with this event, but only from derivative liability arising from my activities in connection with this event. Should any litigation arise from this agreement, the prevailing party at trial and, if taken, any decided appeal, shall be entitled to be awarded its reasonable attorney fees and costs incurred therein.

## 2019 Holiday Light Parade Regulations

### THEME – “Holiday Magic”

1. The Safety of all parade participants and spectators is your primary concern above all other considerations.
2. ALL entries must be illuminated.
3. This is a family friendly event.
4. NO AIR HORNS are allowed as they frighten horses and other parade animals.
5. **All candy or giveaways must be handed out by WALKERS ONLY!**
6. **NO CANDY and/or GIVEAWAYS WILL BE THROWN/PROJECTED FROM VEHICLES, MOUNTS and/or FLOATS.**
7. Entries with animals must provide their own clean up.
8. There is a 14 foot height restriction on all entries.
9. Children MUST be under adequate adult supervision, 5 kids to 1 adult max ratio.
10. Skidding or peeling out of tires is PROHIBITED.
11. All entries must complete a registration form IN ADVANCE.
12. **Santa is contracted by Western Washington County Firefighters Association. NO SUBSTITUTES ALLOWED.**
13. Inflatable and decorative Santa figurines are allowed.
14. All participants will follow instructions from parade volunteers.
15. You will be notified of the staging location one week prior to the parade.
16. Check in at the staging area will begin at 3:00 pm. Each entry will be assigned a specific arrival time depending on their location in the parade.
17. Entry numbers and additional instructions will be issued upon arrival.
18. Entries in violation of any entry guideline will be turned away at the staging area.
19. Parade start time is set for 5:00 pm
